



VAPORIZER TUNE-UP TIPS

With cooler weather around the corner it's time to think about vaporizers. Annual maintenance is critical to ensure they operate correctly when needed. Refer to the manufacturer's instructions for annual maintenance requirements. Below are some general tips to help keep your vaporizer in proper working condition and ready for the season.

All vaporizers will need to have:

- 1. Strainer basket cleaned
- 2. Relief valves cleaned and checked
- 3. If a drip leg or separator is installed, drain as required



Direct Fired vaporizers will need to have the inlet control valves checked. Heat exchangers will need to be cleaned and checked for holes and pitting. Main burner assemblies will also need to be cleaned and orifices checked. Pilot assemblies must be cleaned and thermocouples checked and replaced if necessary.

When all of that is completed, start the vaporizer and check operation of thermostat.

Lastly, check the re-lighter, if equipped. If it's a battery operated re-lighter, replace the battery after verifying the new battery's voltage with a multimeter. Extinguish the pilot and ensure the pilot relights.

Electric vaporizers should have the inlet solenoid valve checked. It should make no noises when operated. The contactor should inspected for signs of discoloration and wear. Inspect wiring corrosion and integrity of connections. Any safeties must be checked as well. A Liqui-Safe valve would be an example.

MINUTEMAN ANCHORS

NFPA 58 (2024) 6.8.1.6: "Where necessary to prevent floatation due to possible high flood waters around aboveground or mounded containers, or high water table for those underground and partially underground, containers shall be securely anchored."



It is generally advised that containers located within FEMA's 100-year flood zone must be anchored. Flood maps can be located online msc.fema.gov/portal/home.








WHAT'S WRONG WITH @ THIS PICTURE?

Is this gas line installed aboveground, underground or both? What is wrong with this picture?

CSST manufacturers have their own installation procedures that must be followed when installing their brand of CSST piping outside.

- 1) CSST piping must be protected from mechanical damage aboveground at sections that are below 6 feet in height.
- From the pictures above, the aboveground portion of gas line is not above 6 feet high and it is not protected from mechanical damage.
- 2) <u>CSST must not be direct buried unless certain criteria are met</u>. The gas line must be sleeved in a conduit with the ends sealed. Some manufacturers also offer a specialized type of CSST that is pre-sleeved and approved for underground installation without an additional sleeve.
- From the pictures above, this is not a properly sleeved and sealed or a pre-sleeved CSST product approved for direct bury use.
- 3) NFPA 54 states that a minimum of 12" of cover is required on any direct buried gas line. If 12" of cover cannot be provided, it must be installed in a protective conduit.
 - From the pictures above, it is doubtful that this installation is buried below 12" or installed through a protective conduit.
- 4) There are some additional questions that need to be answered to determine whether this system meets the installation requirements.
 - Is a shut-off valve and sediment trap installed?
 - Is this CSST piping system bonded per manufacturer's requirements?

As a reminder, manufacturers of CSST require that you are certified to install and service their piping. RMI can help certify your technicians on TracPipe.
